





Founded after the Shanghai Cooperation Organization (SCO) summit held in Shanghai in 2006



In 2011, the CCI of Russia launched a project titled 'Investor Navigating Infrastructure Based on Chambers of Commerce and Industry', which promotes interaction between regional authorities, chambers of commerce and industry of Russian constituent territories, municipal chambers, and the CCI of Russia to seek for, select and foster regional investment projects.

Arbitration and Intermediation

Internationally acclaimed commercial arbitration institutions have been operating under the CCI of Russia for over 80 years:

- the Maritime Arbitration Commission (MAC) since 1930
- the International Commercial Arbitration Court (ICAC) since 1932

The ICAC is a leading arbitration institution; one of the most respected and impartial arbitration centers in the world.

The ICAC provides

- A flexible settlement procedure with residents and non-residents of the Russian Federation
- Arbitration in Russian, English or other languages in accordance with modern international standards
- Disputes consideration does not exceed six months from the moment an arbitral tribunal is formed.

The ICAC makes its decisions consistent with the applicable legal norms chosen by the sides; arbitral awards are enforced in more than 145 states, signatories of the 1958 New York Convention on the Recognition and Enforcement of Foreign Arbitral Awards.



Mediation

Panel of Mediators conducting mediation processes has been operating under the CCI of Russia since 2006. The CCI's intermediaries have settled hundreds of disputes including those involving companies from Japan, the UK, and other countries.



Annually in ICAC:

about 300 international commercial disputes parties - companies from 40-50 countries.

Support to Foreign Business in Russia

Current Russian law vests the CCI of Russia with supporting the activity of branches and representative offices of foreign companies in Russia

- Certification of the number of foreign staff working in branches and representative offices of foreign companies for the purpose of accreditation in Russia;
- Provision of personal accreditation of foreign staff working in branches and representative offices of foreign companies accredited in Russia consistent with the certified size of staff;
- Assistance in obtaining work visas for personally accredited foreign personnel working in branches and representative offices of foreign companies and members of their families;
- Issuance of permits for opening branches and representative offices of foreign chambers of commerce, mixed chambers of commerce, federations, associations and business associations in Russia.

In addition, the CCI of Russia provides visa support for foreign businessmen arriving in Russia for a business visit.


